

Terms & Conditions – Delasport ICE-SuperPot Promotion

The following are the terms and conditions of the "Delasport Ice-SuperPot Promotion" (the "**Promotion**"). The Promotion is organized by Delasport Limited (the "**Promoter**"). Your participation in the Promotion shall be deemed to constitute your complete acceptance of the terms and conditions set out below.

1. The Promotion shall commence at 00:01 on January 6, 2025 and will last until 23:59 on January 19, 2025 (the "**Promotion Period**"); For the purpose of this Promotion, every date and time will be according to Greenwich Mean Time (GMT). Participation in the promotion is free, i.e. no purchase or payment of any kind is required to enter.

2. During the Promotion Period, each participant will be required to predict the results (home win, draw, or away win) of twelve football selections taking place between January 18, 2025, and January 19, 2025, as provided in the Promotion.

Participants will be able to place their tickets from 00:01 on January 13, 2025 until the start of the first football game on January 18, 2025.

3. In order to participate in the Promotion, you must submit a form with your full name, company name and valid company email address; participants trying to register with free/public email addresses, such as Gmail. Hotmail etc. will not be eligible to participate. The form and its submission are available at https://www.delasport.com/superpottournament/ (the "Form"). This Promotion has a cap of 1000 participants. If this number is reached, the Promoter receives the right to stop accepting new registrations.

4. Within 48 hours of submitting the Form, you will receive an email with credentials to allow you access to the promotion via the website <u>1000000bet.com (the "Website")</u>. You can use this access in order to create up to two Promotion prediction tickets (the "**Tickets**") during the Promotion Period, to make your predictions for the Promotion. You may not create more than two Tickets. You cannot create a Ticket after the Promotion Period.

5. The winners of the Promotion will be determined according to the number of successful predictions they made in a single Ticket. In case of a tie between participants with the same number of successful predictions in each participant's Ticket, the winner of such a tie will be the participant who submitted first the applicable Ticket via the Website. Submission timestamp is based on the participant system's server time and that no disputes will be entered into regarding the accuracy of the timestamp.

6. The winners of the Promotion will be announced by the Promoter on January 21, 2025 (the "Date") and each winner must collect his/her award in person at the ICE Barcelona 2025, Delasport's stand on January 21 at 2pm, 2025 and required to present valid government-issued identification to verify age eligibility. If the winner is unable to claim their prize in person, they may designate a representative to claim their award in person, by first notifying the Promoter via email to: superpot@delasport.com until 20th of January 20225. If neither the winner nor his/her representative attends in person as required, the prize will be awarded to the next eligible individual on-site with the highest number of correct selections.

At ICE 2025 the winners will receive a certificate for their prize and within a month of the announcement, the Promoter will send an email to the winners, asking for their addresses in order to send them the Prize.

Additional 10 random winners will be drawn from all participants, each one getting a prize of €100 Amazon Gift Voucher.

In case the 1st place winner gets all twelve selections correct, he / she will also get to donate the accumulated amount in the jackpot, capped to \notin 1500, to a charity of their choice. The winner will select the charity and the Promoter will make the donation in the winner's name.

One participant is eligible to win a maximum of 1 prize.

8. Each winner will be contacted by the Promoter to confirm his or her residential address where the Prize may be delivered. If the Promoter is unable to contact a winner or receive the abovementioned details within 30 days of the Date, that winner will be considered as forfeiting his or her Prize, and will have no claim against the Promoter in this respect.
